

Dear Parent or Guardian and Student,

I want to introduce myself as the instructor for the Driver's Education class. My name is Robert Evans and I'm employed by the Morgan County Sheriff's Office as a Patrol Sergeant and lead driving instructor. I have extensive training in what it takes to drive safely and responsibly and hope to instill my knowledge into the students attending the course. I also currently teach driving at the Aurora Community College Police Academy. Leroy Dilka is the other Instructor-Co-owner of Realdriving LLC. Leroy is the Police Chief for Wiggins Police Department and been the Police Chief for the last 12 years. Leroy went to Denver Police Department and Colorado State Patrol for his certifications on teaching driving to Law Enforcement.

This State of Colorado approved course will consist of 30 scheduled hours of instruction. You may choose to complete the 6 hours of behind the wheel training after the classroom portion is completed.

The classroom portion will start on \_\_\_\_\_, 2010 from 8:00 am to 5:00 pm. The classes will be 8 1/2 hours long with a lunch break. The state requires 30 hours of classroom instruction therefore; a student who misses more than 30 minutes of the classroom portion will have to "make-up" the hours of the class. Depending on the amount of students who sign up for the class a second course may be offered at a later date. If this does occur and a class is missed, the student may "make up" their missing time during the next class. Attached you will find a syllabus containing the specific dates and times of classes.

We will meet at the Wiggins Fire Department meeting room and attendance is mandatory. Upon successful completion of the classroom portion of the course, the student will be allowed to complete the 6 hours of behind the wheel training.

Required Materials:

1. Notebook containing lined paper for personal notes and assignments
2. Appropriate attire (able to be in the sun to change a tire or check vehicle fluids etc.)

Driving Permit Information

- A permit is not required until we start the driving portion of the class
- In order to get a permit you will need an ORIGINAL birth certificate showing you are at least 15 years old and a social security card.
- The student has to complete the 30 hours of classroom before the permit can be issued
- The student must pass the Colorado basic written test, vision screening and pay the license fee. This can be done after the class starts. I will administer the written test from the Department of Revenue, on site, during the last session of classroom instruction.

The refund policy for Realdriving LLC. is as follows: if the student starts the class there will be no refund. If the student or parents elect not to take the class they must give at least 2 weeks' notice in order to get a 100% refund. If there is less than 2 weeks' notice (14days) you will receive a 50% refund.

The Parent – Teen will be required to pay a fee of \$300 for the driver's education class. This will include 30 hours of classroom instruction and 6 hours behind the wheel instruction. The vehicle and car insurance will be supplied by the company of Real Driving LLC. Normal wear and tear on the vehicle will be paid for by Real Driving, LLC.
